服務條款

Terms of Service (TOS)

1. 服務(the Service)

基於活學文教所提供的網路服務的重要性,用戶應同意:

- (1)提供詳盡、準確的個人資料。
- (2)不斷更新註冊(報名)資料,符合及時、詳盡、準確的要求。活學文教不公開用戶的姓名、 位址、電子郵箱和筆名,除以下情況外:
 - 1) 用戶授權活學文教透露這些資訊。
 - 2) 相應的法律及程式要求活學文教提供用戶的個人資料。如果用戶提 供的資料包含有不正確的資訊,活學文教保留結束用戶使用網路服務資格的權利。

Based on the importance of web-content services, the student needs to agree with:

- (1) Providing true, accurate, current and complete information about yourself as prompted by the Service's registration form
- (2) Maintaining and promptly updating the Registration Data to keep it true, accurate, current and complete. LLCE will not disclose the name, address, e-mail and pseudonym of the student, except for following situations:
 - 1) The student grants this Site the right to reveal the personal information
- 2) Under the enforcement of law and order to provide the student's personal profile. If you provide any information that is untrue, inaccurate, not current or incomplete, or LLCE has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, LLCE has the right to suspend or terminate your account and refuse any and all current or future use of the Service.

3. 用戶的帳號,密碼和安全性(User account, Password and Security)
